### GENEALOGICAL TIPS:

The N.C. State Legislature enacted the Homestead Exemption Act in 1868 (Article 10 of the 1868 Constitution. This act prevented the forced sale of homes, it allowed the owner to retain the homesite & such buildings not to exceed \$1,000 in value, this applied to homesteads within the corporate limit of a village, town or city as well as in the country. This act also allowed a person to retain \$500 worth of personal property. These exemptions are generally filed in books labeled Homestead Exemptions.

When estate papers show that many people owed money to a deceased man you might want to check out the possiblility that the man had operated a store or business such as a mill or a blacksmith shop.

The genealogical tips section would love to have your tips. This is the way we can help someone else.

Dobbs Miscellanous Records Call # 34.001

Deed from Joshua Herring of Dobbs Co. to "my well beloved son-in-law Matthew Moseley and Betty, his wife, my daughter." date 22 Feb 1783

Veed from Joshua Herring to "my well beloved daughter, Mary Taylor." 6 Apr 1778

Veed from Henry Taylor & Mary his wife to Robert Taylor (no stated relationship) this land is part of the land deeded to said Mary by Joshua Herring. 1 Aug 1783

Treasurers & Comptrollers Papers - Co. Settlement with the State Box 38 - Dobbs Co.

Apr. Inferior Court 1772

James Grant, poor & infirmed recommended he be exempt from paying taxes & doing public duties.

Oct Inferior Court 1772

Robert Hamilton, Abraham Hays Sr., George Hinson, John Mozingo, all recommended to be exempt from paying taxes & doing public duties as poor, aged & infirmed.

Jan. Inferior Court 1773

female children of Edward Carter to wit: Tamer Deaver, Margaret, Rachel, Anne, Sally, Patience & Elizabeth Carter be recommended for exemption from payment of public taxes, sufficient proof appearing to this court that they are of the 4th generation from a negro.

William Bell, Constable, for keeping John Cato who was committed to his care as a horse thief etc. for eight days & for conveying him to Newbern goal. (This was a draft for Bell's expenses.)

Thanks to the efforts of our members, Carol Peele and Mable Rountree, we will be running abstracts of surviving Dobbs Records in all future issues of our newsletters. The above records were abstracted by your editor. If any of you happen to have an original Dobbs record would you share it with us?

# Coroners' Inquest 1790 -1898 Broken Series

- 1 Nov 1790 George Langston died of drowning in the Neuse River
- 29 Dec 1794 Benjamin Walden died of drowning in the Little River
- 4 Feb 1794 George Bradbury hung himself on a tree limb
- 23 Nov 1795 John Tiner died of accidental means in woods near Johnston Co. line
- 2 May 1811 Robert Peele found dead near landing of Wm. Whitfield of natural causes
- 27 Feb 1813 Exum Hollowell died of a sudden vistation of the Almighty
- 8 Oct 1813 Frederick E. Becton hung himself
- 5 May 1813 Jesse Bizzell hung himself at John Bizzells (oath of John & Abigail Bizzell)
- 1 Oct 1827 Elizabeth Williams wife of Levi Williams drowned herself in the Neuse River at Micajah Cox's
- 26 Nov 1829 Lewis Freeman died of drowning in Neuse River at John B. Hurst
- 4 July 1830 John Powell of Sampson Co murdered by Lewis Edwards
- 6 July 1830 David Anderson hung himself near the house of Sally Mitchell
- 10 Nov 1832 Mason Gin (sic) died of exposure on night of 8 Nov
- 25 May 1835 Willis Hines died of drowning opposite the landing of Allen Whitfield
- 8 Dec 1836 Joseph Benton froze to death
- 12 Dec 1836 Benjamin Rodgers froze to death
- 23 Dec 1836 child of Elinder Thomas died of natural causes
- 19 Nov 1836 Shadrick Daniel murdered by a blow on the head with a piece of timber by one Etheldred Howell
- 24 May 1836 Nathan Perkins died of drowning
- 27 Apr 1837 Shadrick Thompson died of drowning
- 12 Jan 1837 Edward Mozingo died of freezing
- 16 Apr 1839 Joseph Enos late of New Hanover Co died after falling from the train as it crossed West Bridge near L. H. Whitfield's
- 15 Apr 1845 Wiley Garris shot himself
- 4 Feb 1846 Noay (Noah) Hedgpeth killed by a falling tree

INSTRUCTIONS FOR FILLING OUT FORMS

- . Please print clearly or type all forms. Information will be printed by computer; check your forms for accuracy and legibility.
- 2. There must be a North Carolina reference for each ancestor; that is, NC must appear as place of birth, marriage, or death OR a North Carolina county must have been a place of residence.
- 3. Enter the surname in the upper left corner of the form in the space indicated. The same surname should be repeated in the numbered spaces in the body of the form. Alternate spellings may be entered as follows: Schmidt/Smith or Kerr/Carr, etc. Do NOT use Jr., Sr., III, etc.
- . Given name(s) follow the surname in the numbered spaces. Do NOT include military, professional, or courtesy titles, such as Dr., Colonel, Rev., etc. Alternate spelling of given names may be entered as follows: Elizabeth/Betsy, John/Jack, etc.
- 5. When entering the PLACE enter foreign country, or state. If the state is North Carolina, enter the county, if known. Do NOT enter counties in other states.
- VA. MS (for Mississippi), TRE, SCO, ENG, GER. If you think this may not be clear, write the full name on the back of the form. Write out North Carolina county names. If there is some uncertainty as to PLACE, enter as ?NC or ?Chowan (meaning Chowan County, NC).

- FEES: \$1.00 for the first ANCESTOR (not SURNAME) listed and \$.50 for each additional ANCESTOR. If additional forms are sent at a later date, please note the date of the \$1.00 first-entry fee. Payment should be to the North Carolina Genealogical Society.
- DEADLINE: All forms and fees must be returned to the Society at the address on this form prior to JULY FIRST, 1983.
- 7. When entering the date, enter only the year. If the date is approximate, enter as c1798, c1817, etc. If there is uncertainty as to the date enter as ?1798, ?1817, etc. Do NOT enter inclusive dates, such as 1794-1800.
- 8. There are spaces for listing three marriages. If your ancestor married four or more times, enter the information on the back of the form.
- 9. The wife should be listed with given name(s) followed by maiden name, if known. If she had been married previously she should be listed with given name, maiden name in parentheses, followed by the earlier married name, such as, Mary (Smith) Jones. If you do not know her maiden name but wish to indicate that she had been previously married, enter as Mrs. Mary Jones. If the wife's surname at the time of her marriage is the same as the ancestor's, please underline hers, as Mary Jones [who married ancestor John Jones]. You may enter only the given name(s) of a spouse if the surname is not known.
- 10. To include a spouse's dates of birth, death, etc., he or she must be entered under the relevant surname. For instance, the above fictional Mary Smith would be listed on a SMITH surname sheet.
- 11. Fill out your own name and address. Read, sign, and date the "privacy statement".
- 12. You may include any documentation on the back of the form.
