Ms. Frances Parkinson also sent us the following copy of the rejected Revolutionary War pension petition for Ezekiel BENBROOK (1748-1840).

DECLARATION IN ORDER TO OBTAIN THE BENEFIT OF THE ACT OF CONGRESS OF THE 7th JUNE 1832

State of Indiana Posey County

On this 10th day of September A.D.1834 personally appeared before the judges of the Posey Circuit Court, the same being a Court of Record, Ezekiel Beinbrook a resident of Mars Township, Posey County, Indiana aged 85 years in December next who being first duly sworn acco; rding to law doth on his o;; ath make the following declaration in order to o; btain the benefit of the provision made by the act of Congress ---- passed June 7th 1802 - states that he was born in the year 1748 in Doubs County as it was then called (its name has since been changed - by what name it is now known declarant does not recollect) - removed from Doubs County to Mongomery where he resided when he entered the service of the United States in the year 1779 - (if his memory be correct) in the capacity of Lieutenant in a company commanded by Captain Thomas Child - his commission of Lieutenant was given him by General Rutherford. Served in said company for the term of six months - marched from Mongomery to South Carolina with the intention of going to Eutaw Springs - Had marched to within about 25 miles of Eutaw Springs when our colonel received information that our services were required on Drowning Creek (as it was then called) and by the enemy's changing their position we returned to Montgomery in North Carolina where we started from. While on our return from our march towards Eutaw Springs , we had a battle on Drowning Creek at Beaty's? Bridge, Colonel Culp & Colonel Wade & Major Marsh? commanded in this engagement. We were whipt and beaten so that we were put to flight.

Removed to Wilks County in the state ;of Georgia, lived there about 10 years then removed to Carolina again where he resided until about the year 1807 when he removed to the state of Kentucky, Warren county. From there he removed to Mars Township in Posey County Indiana where he now lives. Says he has a record of his age at his son-in law's with whom he lives -- Says that his commission was signed by Gen'l Rutherford, Says that when he was preparing to remove from North Carolina to Kentucky his commission with other papers his wife burnt not thinking that it would ever be any service to him. His discharge was also burnt at the same time. Says that he has no documentary evidence whatever to prove his services nor does he know of any person or persons by whom he can prove his personal services as a soldier & officer of the Revolution. Says that he served the full term of six month as Lieutenant as above stated. For which he claims a pension. He hereby relinquishes every claim whatever to a pension except -- or an annuity except the present and declares that his name is not on the pension roll of any county of any any state or township. Affadavit sworn to in open court this day and year aforesaid.

The following letter is what I recieved from the National Archives when I sent of for copies of an ancestor's claim to the Southern Claims Commission. (See our December 1987 newsletter.) Enclosed with the letter was NATF Form 72 (9-85) which I filled out and returned with the amount asked for copies (\$5.00 minimum).

Dear Ms. Beason:

In response to your letter of September 24, we searched the records of the Commissioners of Claims (the Southern Claims Commission) among the records of the U.S. House of Representatives. The results of our search follow.

The Commissioners of Claims, popularly known as the Southern Claims Commission, was created in 1871 by an Act of Congress to settle the claims of loyal citizens of the South for stores and supplies taken by the United States Army during the Civil War.

According to statute there were two instances by which claims were "barred" due to inaction by a certain date. instance relates to the initial filing of a petition for a claim, while the other pertains to the subsequent submission of evidence. In order to receive any consideration by the Commissioners, a petition for the allowance of the claim had to be filed by March 3, 1873. Any claim filed after that date was "barred from consideration, regardless of its merits." For those filed by that date, each claimant was required to assemble all possible evidence showing his or her right to payment for stores or supplies lost. An Act of June 15, 1878, provided that the Commissioners of Claims would not accept any evidence on behalf of claimants filed after March 10, 1879, except in rebuttal of evidence introduced on behalf of the Government. All claims for which evidence was not filed by that date were also "barred forever thereafter."

The papers in the disallowed or barred Civil War claims listed below are among the records in our custody. We can provide copies of these claims for 35 cents per page with a minimum order of \$5.00. Before we can provide copies, however, you must obtain authorization for that purpose from the Honorable Donnald K. Anderson, Clerk of the U.S. House of Representatives, The Capitol, Washington, DC 20515. When you have received authorization, please send a check or money order, payable to the National Archives Trust Fund (NNLR), to the National Archives Trust Fund Board, PO Box

100793, Atlanta, GA 30384. Please enclose your payment along with the white and goldenrod copies of the NATF form 72 in the attached envelope. The pink copy of this form is for your records; consult the back of it for further information.

For those of our membership who would like to know more about Dobbs County, here is a short history of its formation and some maps showing approximate boundries. While it was a county, Dobbs held parts of many of the surrounding counties so it is sometimes very confusing to try to find old records. We try to publish what we can of Old Dobbs, but because we are based mainly in Wayne County, we have more on Old Dobbs and Wayne County than on some of the other counties who made up part of Dobbs. If you have, or know someone who has, more information on Old Dobbs County, please let us know so that we can publish it.

FORMATION OF DOBBS COUNTY

Dobbs County was formed in 1758 from Johnston County. It was named in honor of Arthur Dobbs, an Irishman, who was governor of North Carolina from 1754 to 1765. Dobbs County was abolished in 1791. From the book The Formation of The North Carolina Counties, 1663 - 1943 by David LeRoy Corbitt. I am reprinting copies of the actual descriptions because they contain so many names.
