MINUTES OF JUNE MEETING

A regular meeting of the Old Dobbs County Genealogical Society was called to order at 3:00 pm June 8, 1986 in the auditorium of the Wayne County Public Library by Mary E. Spiron, President.

The members and visitors were welcomed by Mrs. Spiron.

The minutes of the May meeting were approved as printed in the June newsletter.

Yvonne C. Hatch, Treasurer reported that the outstanding bill at the Court House for the marriage applications, both black and white, from 1878 to 1882 had been made and the applications received.

Announcements were made as follows:

Naturalization records for the New England states/were previously at the National Archives in Washington, D. C. have been transferred to the Boston archives branch. The material consists of "dexigraph" copies of petitions from federal and nonfederal courts in Maine, Massachuetts, New Hampshire, and Rhode Island made by the Works Progress Administration and card indexes for all six New England states. The period covered is the late eighteenth century through 1906.

The September/October 1985 issue of the NGS Newsletter reported the action taken by the State of Wisconsin against Beatrice Bayley, Inc., a publisher of "family heritage" books. The January/February issue of the Newsletter reported on two proceedings brought by the U. S. Postal Service against the same. The May/June issue informed us that there is a Beatrice Bayley and Clone. The NGS has reported that people are receiving solicitations for a "family album" from "Elizabeth Ross" for American Genealogies Inc., P. O. Box 1610, Plainfield, NJ 07061-1610. The solicitation cards closely resemble those used by Beatrice Bayley, Inc. NGS has been informed by the Postal Service that this matter is under investigation and was asked by the Postal Service to forward copies of materials received by members. Anyone who receives a solicitation through the mail for a family heritage book or similar product that he or she believes to include false representations is invited to send the solicitation materials to the National Genealogical Society Newsletter Editor, 4527 17th Street, North, Arlington, VA 2207, so they can be brought to the attention of the appropriate office of the U.S. Postal Service.

The Marriage Applications purchased by the society have been bound into four volumes. They will be made available, at each meeting, for the members

SIMPLIFY YOUR RECORDS

By Mary E. Spiron

To simplify your research you need to give each of your direct ancestors their own individual number. This number should be the same on the Pedigree Chart and the Family Group Sheet. By each person having their own identification number the duplication of names will not be so confusing. For example, Thomas Gwaltney #272 on Chart 10 and Thomas Gwaltney #272 on Chart 13 is the same person. He is shown with his first wife Mary Goodman #273 on Chart 10 and with his second wife Hannah #365 on Chart 13. REFER TO PAGES 5,6,and 7

See Family Group Sheets: Directly above the word HUSBAND the number 272 appears for Thomas and above the word WIFE is the number 273 for Mary on one sheet and #365 for Hannah on Sheet II.

The formula to determine the <u>number</u> for each of your <u>direct ancestors</u> is as follows: Take the number of your Chart Subtract 1 Multiply by 30 Add 2 This is the number for the first person on your Chart. Continue to number in

consecutive order working from top to bottom across the sheet. The males will have even numbers and the females odd numbers.

Example: Chart 10----10 minus 1, times 30, plus 2 = 272.

NOTE: This formula is for the 5 generation charts. Other charts will have to be adapted according to the number of generations shown on the chart.

Example #2: Chart 13----13 minus 1, times 30, plus 2 = 362.

The first male on Chart 13 is #362. Although Thomas is #272 his wife Hannah is #365. Also note that Thomas, the father of Thomas, keeps the number of 274 as shown on Chart 10 and that William, the father of Thomas keeps his number of 278 as shown on Chart 10. Also the wives of Thomas #274 and William #278 maintain the same numbers that they had on Chart 10.

Charts 10 and 13 show how I came about having a double Gwaltney line. William and Benjamin were half brothers. Their children which were half first cousins married.

REMEMBER: Documentation is the KEY in research. Refer to the Family Group Sheets. The asterisk with a number next to any data corresponds to the same number at the bottom of the sheet thus giving you the source of the information.

"PEDIGREE" - "LINEAGE" - "ANCESTRAL" CHARTS

Regardless of the term you use, your Pedigree Chart will be the most popular product and the skeleton of your research.

Your first Chart is numbered as Chart 1. You continue down the right side of the chart through number 17. Chart 2 will start with 18 and go through 33 and so go. However, suppose you do not need to continue on chart 2 at the present time but you need to continue on chart 10. Instead of numbering nine charts, you can use the following formula for the chart you need.

Take the chart number that you desire Subtract 1 Multiply by 16 Add 2

Example: Take Chart 10. 10 minus 1, times 16, plus 2 = 146

Therefore, you begin the first line on Chart 10 with 146 and go through 161

Example #2: Take Chart 12. 12 minus 1, times 16, plus 2 = 178

Example #3: Take Chart 13. 13 minus 1, times 16, plus 2 = 194


NOTE: This formula is for a 5 generation Pedigree Chart. Other charts may be adapted by using the number of generations on the chart.



WAYNE COUNTY'S DOUBLE SIR NAMES

For a time I have been puzzled by the several double last names that show up in the early records of Wayne County. The most notable example being that of John Coor Pender, the county's second sheriff. We have all been taught that wide spread use of "middle" names did not appear until about the middle of the eighteen hundreds. In addition, none of our examples meet the criteria to be a misunderstood profession, Tanner, Taylor, Carpenter, etc. No approach I took explained why John Coor Pender's wife was called Bethany Coor Pender, or his children Lewis Coor Pender, John Coor Pender (Jr.), Charlotte Coor Pender, Pheriby Coor Pender, nor the number of others in the records with the same names: Harphrey Coor Pender, Sally Coor Pender, Grace Coor Pender, Tabitha Coor Pender, and Elizabeth Coor Pender.

At times this name is abbreviated to C^r Pender or C. Pender, or at times is written all together, Coorpinder, all with various spellings. Sometimes one name or the other is missing completely. You may find it indexed eith with the C's or with the P's.

Other names that I have located with potentially the same problem but not in such numbers are the Ballard Boyte boys, Joseph and Jacob, and Arthur Dobbs Young.

A clue to this mystery may be found on pages 29 and 30 of <u>A</u> <u>Guide to Seventeenth-Century Virginia Court Handwriting</u> by Kent P. Bailey and Ransom B. True (Richmond, 1980). These names were probably meant to be hypenated (Coor-Pender). The authors of this book state that in researching the seventeenth-century court records of Virginia a few hypenated last names were found. As to its use, the example was given of a widow, Alice Cole, who married a Mr. Marsh. She took the name Alice Cole-Marsh which she also gave to her children.

The proof that this system was still used by some in Wayne County in the late eighteenth-century is in a comparison of the loose estate papers of John Ballard (NC A&H Search Room) and in Wayne Deed Book 7 page 10. Jacob and Joseph Ballard Boyte petition the court for the money they did not receive for education from the estate of their father, John Ballard. The deed is a gift from Sarah Boyte to her son, Joseph Ballard Boyte.

Having come into this mystery in the middle, I'm interested to

know at what point did the individual or the family hault the double name? The Ballard Boyte boys were well into middle age at the time Sarah gave the property to Joseph. John Coor Pender passed his acquired name on to his children, but this combination survives in the county now only as a given name in the Pate family.
