We are delighted to announce a workshop sponsored by the Old Dobbs County Society on S. C. Records. We are indeed fortunate to have Mrs. Beverly Shuler as the lecturer. Mrs. Shuler is a resident of Mt. Pleasant, S. C., a graduate of Converse College, received her Masters degree in Socialogy from the University of Ga., she is a Certification Genealogical Records Searcher (this ia a national certification by the National Genealogical Society). She was a Panelists at the workshop on Souther Records, sponsored by the National Society in 1981. A panelists for five years on the Institute for Genealogical and Historical Research, a yearly event conducted by Samford University. State Archives...what a disappointment! No original records are available for you to use, everything is either published abstracts or on microfilm. The original material is still in the counties, therefore genealogical research in Tn. is much more time consuming and costly than in N.C. Why not drop your state senate and representatives a note and tell him what a top-notch archives and staff we have? GENEALOGY CLASSES BEING OFFERED:

GENEALOGICAL HINTS:

Are you trying to find an elusive great grandfather? Don't overlook the Voter Registration Act of 1902-1908. Often called the grandfather voter clause, this is a listing of all men who registered during this time period and is based on their ancestor who was a qualified voter prior to 1867. The lists are done by county and therein by townships and include the name of the man registering to vote, his age, the name of his voting (or qualified to vote) ancestor and the date of the registration. These records are on microfilm and can be inter-library loaned. The full title is: Secretary of State Voter Registration Records, 1902-1908. Call number and order reference for Wayne Co. is S. 108.132N. In using them remember that the list are by townships and so you would be wise to check all townships.

Are those old newspaper clippings that you've been holding on to for so many years turning yellow and threatening to crumble! Experts at the National Archives, who have the same problem, suggest the following method of preserving old newspapers:

Mix 2 teaspoons of magnesium carbonate and a quart of club soda in a large plastic dish. Sandwich the clippings between two pieces of screen made of Pellon (a fabric sold in most fabric stores). Soak for 30 minutes. Mop up excess liquid with blotting paper and allow to dry overnight on more blotting paper. After using the preservation technique, store the clippings in a well sealed plastic bag. They should keep forever!

Wills between 1663 and 1760, no matter where probated or where the man lived were filed with the Sec. of State. The one exception to this was Carteret Co.
