The Old Dobbs County Genealogical Society met on April 24, 2004 at the Wayne County Museum in Goldsboro, NC to kick off our membership drive. Our president, Lisa Corbett, called the meeting to order, welcomed the members and guests, and led us in the Pledge of Allegiance. There were 22 people present. Since there were several guests, our present officers were introduced and Lisa gave a brief overview of the Olde Dobbs County Genealogical Society. The minutes from our previous meeting were approved as printed in the newsletter.

Regarding the cemetery books, Cathy Blow reported that volunteers are still needed for surveying cemeteries and that Volume 1 will soon be ready for indexing.

It was announced that Old Dobbs will do a "hands on" type workshop in the fall at the Wayne County Public Library. It has been suggested that the first workshop be geared toward beginning genealogists with later workshops to be more advanced.

HOUSE BILLS

FOLDER DEC 13

Dec 20 - Bill to alter the names and legitimate - 1<sup>st</sup> be it enacted by the General Assembly – the name of Judith Williamson, the illegitimate daughter of William Dickinson and Julia Dickinson

of the County of Wayne be altered to Judith Dickinson; 2<sup>nd</sup> be it enacted that the name of Narcipa Kellingsworth of said County, the illegitimate daughter of Blake Hooks and Peggy

Hooks be altered to that of Narcipa Hooks --- they are hereby declared to be legitimate and forever shall be capable to possess, inherit and enjoy by descendency estate real or personal

Dec 23 – Bill prescribing the times and places of electing the members of the General Assembly for the County of Wayne, Members of Congress and elections for President and V. President of the U. S. --- shall be held on the 2<sup>nd</sup> Thursday in August in each and every year in each Captain's District at the usual place except at the Courthouse; it is the responsibility of the Court of Pleas and Quarter Sessions to appoint one Justice of the Peace and two free holders in each Captain's District

Dec 24 – Bill to amend an act papered in the year 1820 regarding the marriage of infant females – it shall be lawful for any person to marry a female infant under the age of fifteen provided the consent of the parents or guardians

Dec 27 – a Bill to prevent persons from educating slaves – any guilty person do pay the owners of the slave the sum of 50 pounds for ever offense; if anyone attempts to educate his or her own slaves, the fine is also 50 pounds per offense

BOX 2 – SENATE BILLS – Nov 25 – Dec 20

Dec 2 – a Bill to restore to credit George Jernigan of Wayne County – as never been convicted of a crime

#### Powers of Attorney

In trying to find what happened to siblings of your ancestors, check the powers of attorney. They can be found in deed book indexes and are listed as P.A.s. Some examples:

Bk 18, p 115 – Silas Andrews & wife Charity of Gibson Co., TN appoint Solomon Bradbury of Wayne Co., NC as lawful attorney to sell land which Charity as a child and legal heir of John Worrell, dec'd, late of Wayne Co., was willed dated 6 Nov 1838, recorded in Feb. Term Ct. 1839

Bk 19, p 368 – Elisha Aycock of Houston Co., GA appoints Irving Aycock of Randolph Co, GA to recover from Timothy or Simon Aycock of Wayne Co, NC such legacy bequeathed him by his grandfather, Jesse Aycock dated 2 Dec 1842, recorded Aug. Term Ct. 1844
