LETTER FROM THE PRESIDENT

Dear Members:

Some of you may not know that we in Old Dobbs County Genealogical Society are a major component of the Wayne County Historical Association, and fall under the 501(c)3 Tax-exempt status of the Historical Association.

At our June 1994 meeting the new WCHA By Laws were presented. These By Laws were written by an Ad Hoc Blue Ribbon Committee. Your President sat on this committee. WHICH ELISHA UZZELL?

Too many branches of the Uzzell family claim to be descended from Elisha Uzzell, Jr., son of Elisha Uzzell, Sr. of Wayne County, North Carolina who died in 1798. It has been my goal for several years to identify the real Elisha Jr. and assign the other "Elisha's" to their correct fathers. After gathering extensive records, I submit the hypothesis, based on circumstantial evidence, not hard facts, that the real Elisha Jr. is the Elisha Uzzell of Muhlenberg County, Kentucky. If any Uzzell researcher can offer proof that this is wrong, I would welcome the information!

There were Elisha Uzzell's in several areas of the country at the same time. By collecting data on each, the "real" Elisha, Jr. could be identified, I reasoned. A summary of the information on each Elisha is listed below.

Elisha Uzzell of Franklin County, North Carolina - This Elisha has been claimed by his descendants as the Elisha, Jr. named in Elisha Sr.'s will probated in 1798 in Wayne County. As this Elisha was born 29 Jan 1787, according to Bible records, he would not have been old enough to be the Elisha, Jr. who helped his father with surveying, and who was listed on the 1790 census as "Elisha Uzzell, Jr." In order to be the head of a household, a man had to be twenty-one. This Elisha was married to Tabitha Boon who was born in 1797, and their first child was born in 1817. The "real" Elisha was witnessing court records, etc., when this Elisha was just a small child. According to articles in the Wayne County Heritage Book, this Elisha was the "real" Elisha Jr. but it appears to be impossible. So who was his father?

Elisha Uzzell of Maury County, Tennessee - He first appears on the 1820 census in Maury County, with a wife and twelve others in the household. The Maxwell History on page 336 says that this Elisha was from Isle of Wight County, Virginia, and his father, Thomas, emigrated from France to America as a commander of a ship under LaFayette. Again, the dates do not match. This Elisha could have been a descendant of Thomas, as the immigrant's son, James, stayed in Isle of Wight County and had numerous descendants there, while his brother, Thomas, went to North Carolina, and established a large family in that state. This Elisha appears on the tax list of Maury County in 1817 and married according to some records, Ann Cohea. Who is this Elisha?

Elisha Uzzell of Muhlenberg County, Kentucky - This Elisha is the "real" Elisha Jr., if the circumstantial evidence listed below is correct. Elisha, Sr. wrote his

will in 1795, leaving each child twenty-five shillings except for Feraby Wilson, who received eight shillings. This handwritten will is in a distinctive writing style that closely matches that of the Elisha of Muhlenberg County who served as court clerk, justice of the peace, and sheriff. On Elisha Sr.'s will his signature is very shaky, obviously signed by either a very sick or elderly person, and obviously different from the writing in the rest of the will. The witnesses are also in different handwriting styles. The will was probated in October 1798. Elisha Jr. appears on the tax list in Muhlenberg County in 1799. In the 1800 census there is not an Elisha Uzzell in North Carolina; the only one in the country is in Muhlenberg County, Kentucky.

Below is a list of other circumstantial items of interest:

1. On Jan. 16, 1793 Elisha Sr. deeded to Elisha Jr. 200 acres. Elisha would have to be at least 21.
2. Elisha of Muhlenberg County was skilled in surveying according to court records. The "real" Elisha Jr. in Wayne County helped his father in surveying.
3. Elisha of Muhlenberg County was involved in many court activities. His signature and writing are on numerous documents. This signature matches a signature on a deed to Wilson heirs in Wayne County. These heirs were the children of Feraby Uzzell Wilson who was the sister of the "real" Elisha Jr.
4. Although no will has been found for Elisha of Muhlenberg County, his known children's names are similar to the children of Elisha Sr.: Lucretia, Feraby, Polly, Elisha.
5. The families in Wayne County have many connections with families in Muhlenberg County: Stanley, Moore, Whitfield, Smith, Bennett, Oates, Goodman, Jernigan and Mercer. Many of these families were neighbors of Elisha Uzzell in Wayne and Dobbs Counties, N. C.
6. Isom Uzzell was in the Hopkins/Muhlenberg County, Kentucky area by 1818. His son, Bennett B. Uzzell, married Lurohannah Oates, daughter of Jethro Oates. Isom settled in Missouri and later his son, Bennett, joined him there. About the same time, Elisha B. Uzzell, Jr., son of Elisha Uzzell of Muhlenberg Co. also went to Missouri. Isom's brother, Thomas Jordan Uzzell, went from Sumner County, Tennessee to Marion County, Illinois. Thomas named his son Elisha A. Uzzell. There is a court record in Sumner County, Tennessee in which Isom is sued by his children because he kept the slaves that had been left to their mother, Nancy, granddaughter of William McKinne. In Johnston County, NC, Isom married Nancy Blackman in 1791. Her mother was the daughter of William McKinne who died in 1786. Johnston County is adjacent to Wayne County. Isom's

daughter, Polly, married Allen Groves in 1806 in Sumner County, Tennessee and moved to Hopkins County also. Isom's other daughter was named Zilpha. Elisha Sr. of Wayne County had a sister named Zilpha who married James Pearsall, Sr. Nancy Uzzell of Muhlenberg County had a daughter, Pearcey, born about 1805, the only time that name appears. Is this a nickname for Pearsall? The Maxwell History says that Isom was the son of Benjamin Uzzell, the son of Thomas Uzzell and brother of Elisha Uzzell Sr. of Wayne County. However, other family records list no son of Thomas named Benjamin. Most family records list Isom as the son of Thomas, Jr. brother of Elisha Sr. The connection between the Uzzells of Wayne County and the Hopkins/Muhlenberg County areas indicate that there was definitely family connections.

7. Elisha of Muhlenberg County was married to a woman named Chelly according to a deed in 1819. This name is found in Wayne County records, especially in the Goodman family. In Lenoir County, Chelly Goodman entered a claim for 50 acres on the west side of Whitely Creek adjacent to Henry Goodman. In 1809 in Muhlenberg County Stephen Standley was given letters of administration on the estate of Silvy Goodman, deceased. Elisha Uzzell and William Standley were his securities. The orphans of Silvy were Martin, Penny, and Chelly. Chelly Uzzell died 24 May 1843, according to the Concord Baptist Church Minutes. In the Hopkins County census, Chelly Uzzell is listed as head of household with 2 males and 2 other females in the household. Her age listed would have shown she was born between 1760 and 1770. Elisha of Muhlenberg was born about 1765. More research on the Stanley families of Wayne County, N. C. and the Stanleys of Muhlenberg/Hopkins Counties, Kentucky may show more connections on the Uzzells also, as Elisha Uzzell Sr.'s wife was Dorcas Stanley.
8. Another Uzzell, James, appears in Muhlenberg County on the 1802 tax list. That is the only year he is there. James appears on the 1810 census in Wayne County.
9. On Hardy Hynes(Hines) Revolutionary War Pension application, he stated he enlisted in Dobbs, Wayne County on April 16, 1776. He was allowed pension while a resident of Muhlenberg County in 1818, age fifty-nine. He died March 22, 1832 Posey County, Indiana. His wife, Sarah, stated she had twelve children: Feraby, born May 25, 1788 and the youngest one, Chelly, born March 10, 1807. An affidavit by Elisha Uzzell stated that he had known Hardy Hynes for a "great number of years." If he had known him for a long time, it had to be in Wayne County. Note the names of the daughters. In Hopkins County 1870

census is a Chelly Slaton, born 1807 in North Carolina. Was this Chelly Hynes?

10. In Deed Book 12 of Wayne County deeds, Lewis Jernigan made a deed to Elisha Uzzell, a resident of the state of Kentucky, for land in the state of Tennessee, that was bounty land which was given to his father, Gardner Jernigan, for his service in the Revolutionary War. It was witnessed by Major Uzzell, son of Elisha Sr. It was dated April 14, 1823. At this time, the only Elisha Uzzell in Kentucky, was Elisha Uzzell of Muhlenberg County. On February 17, 1824, Elisha Uzzell sold his personal estate to Calvin Uzzell. It was witnessed by Chelly Moore and John W. Uzzell. There are no other records after that day in Muhlenberg County or Hopkins County for Elisha Uzzell, Sr. As mentioned before, Chelly Uzzell appears on the 1830 Hopkins Census as head of household. Attempts to find the land Elisha bought in Tennessee have failed. Where did he go? Travel was risky in 1824, especially for a sixty-year-old man.

Apparently the southern Uzzell families are descended from the Isle of Wight County, Virginia families of James and Thomas on the tax list in 1782, and the North Carolina families shown in Wayne and Dobbs Counties: Elisha Sr. and Elisha Jr. in Wayne County, and Thomas Uzzell and Isum Uzzell in Dobbs County. With the destruction of so many of the court records I fear that all the descendants of these men will not be found. The Isum Uzzell in Dobbs County presents another mystery since the Isum Uzzell later of Missouri did not marry until 1791; could he be an Isum Jr. or even a nephew? Isum of Lenoir County sold land in Wayne County granted to Thomas Uzzell on Mill Branch, 85 acres in Feb. 1792. This usually showed father-son relationship.

Elisha Uzzell of Muhlenberg County, Kentucky appears to be the son of Elisha Uzzell, Sr. of Wayne County, North Carolina. Attachments include copies of his signature on various documents, a family group sheet showing what is known about him, and a copy of the deed abstract from Lewis Jernigan to Elisha Uzzell of Kentucky. If anyone can add to the information in this paper or contribute facts instead of circumstantial evidence, please get in touch.

Pedigree Charts




